Little Platte Lake Association Meets

HONOR - The Little Platte Lake Association held its annual meeting on June 21 at the Homestead Township Hall in Honor. Members learned what the Association has accomplished since last year's meeting. LPLA continues to monitor the water level of the lake in relation to that ordered by the Benzie County Circuit Court. The loon platform placed on the lake by LPLA with DNR approval turned out to be a mallard platform this year. After efforts to obtain a fish count from the DNR fizzled, the Grand Traverse Band of Ottawa and Chippewa Indians stepped up and conducted a survey last July, the results of which were discussed. Water testing and plant mapping efforts are continuing at the lake.

The business portion of the meeting was recessed for a brief presentation on boat safety by Deputies Ted Schendel and Rick Robbins from the Marine Patrol Division of the Benzie County Sheriff's Office. After their talk on boat safety the deputies answered questions from the members as to such things as registration requirements and reporting offending boaters.

The members then elected directors to serve on the Board until next year's meeting: President Ronnie Brown, Secretary Gretchen Staub, Treasurer John Ester, and Trustees Lynn Walker and Dave Van Hammen. Minutes Of 2008 Meeting

LITTLE PLATTE LATE ASSOCIATION MEMBERSHIP ANNUAL MEETING JUNE 21, 2008

The LPLA Annual Meeting was called to order by President Ronnic Brown at 10:10.

- The minutes of the 2007 LPLA Annual Meeting have been available on line at our web site. Chuck Retallick made the motion to accept the 2007 minutes, Char Ester seconded the motion and it carried.
- Treasurer John Ester presented the proposed budget as well as explained a cash flow comparison from 2006 through 2008. The state of the budget looks good with many people renewing their memberships at enhanced levels. Most of the members paid dues with the return envelopes provided earlier by mail. This system is not only easier for the breasurer but also allowed the meeting to begin more quickly because prepaid members did not have to take the time to pay upon entering. Our account balance is up also because we had reduced expenses this past year. Gretchen Staub made a motion to accept the report, Lou Glatzer seconded it, and the motion passed.
- John Ester also gave a membership report stating that 220 membership applications/renewals had been mailed out this spring with 57 households responding. According to county records Little Platte Lake is surrounded by 337 parcels of land with 220 parcels assigned local addresses and privately owned. The association will try to do the bulk of its communication by email to save postage and the work of organizing and printing mailings.
- Lynn Walker gave a very informative presentation on the state of the watershed. There was much discussion of the dam at Deadstream and how it is maintained to attempt to keep the water level as constant as possible. With the drought last year and the heavy rains this spring it has fluctuated upsetting peoples' shore lines.
- Dave Van Hammen reported that the DNR has also been testing Little Platte Lake's water since 2004 along with sampling Platte Lake's water. The data can be found on the Platte Lake Improvement Association's web page: www.plate-lake.org. There will be a presentation of data at the Platte River Fish Hatchery June 30th at 10:00AM that we are invited to attend. We have purchased collection equipment for this year but may decide to stop doing our own sampling if it is being covered and paid for by the DNR.
- Ronnic Brown went over the fish survey that was conducted on Little Platte last year by the Chippewa and Ottawa Tribe last summer. Not all results are in yet but the lake looks to be producing great pan fish and hass. Providing cover will continue to help these species flourish.

- y Retallick made a mution to briefly recess the meeting when the officers of the Benzie Marine Patrol arrived at 10:45. Pete Preston seconded the motion and it carried unanimously. Officers Rick Robbins and Ted Schendel spoke and answered many questions about water safety. The bottom line is use common sense on and around the water. They also left the <u>Handbook of Michigan Laws and Responsibilities</u> for everyone.
- The meeting resumed at 11:05 with a brief explanation of the aquatic plant mapping project that Gretchen Stub started last year and hopes to finish this year. The final map will be found on the web site when completed.
- Ronnie Brown brought in several hats and a t-shirt printed with the LPLA logo. Most of the hats sold before the meeting and there was interest to pursue sweatshirts, t-shirts, and more hats. The Board will look into this matter and make information available on the web.
- Char Ester made a motion to have signs made reminding boaters of the shallow depth of the lake for the two public access sites. These will replace signs which had been taken several years ago. Lou Chatzer seconded the motion and it carried.
- A developer has purchased land above Deadstream Road with the plan of selling hilltop home sites overlooking. Platte Lake. The plans will have to be approved by the township planning commission before any action can be taken.
- Lou Glatzer ran the election of the Board of Directors. There were no nominations from the floor and the board members were unanimously elected for the accoming year.
- Gretchen Staub made a motion to adjourn the meeting, it was seconded and carried. The meeting was adjourned at 11:22.

2008 ANNUAL COMMITTEE REPORTS

WATER LEVEL - Lynn Walker

Last summer, our watershed dropped 8-12" below normal due to the lack of snow in the winter and rain in the spring of 2007. From April to the end of July 2007, we received only 3" of rain. The last time this occurred was the drought years (1954-1956) summers), which got residents of Little Platte Lake to start a petition for the Dam.

This spring, (2008) we were back to normal due to winter snows of 151"and 8"of rain as of June 4, 2008.

The lake level had dropped at the Dam to a 1.5 reading from the 1.8 legal limit. Boards were put in as of May 30, slowly bringing up the lake level to out legal limit of a 1.8 reading.

Fish Survey by Grand Traverse Band of Ottawa and Chippewa Indians

"This is a summary of our catch, cursory evaluation, and map of net locations. We collected over 300 scale samples from bluegill, pumpkinseed, largemouth bass, rock bass and smallmouth bass. Those data will take some time to compile. These are the data we use to calculate growth indices. I expect to find in most cases species are growing near State average as observed by the MDNR, but I can't say for sure until the scales are read. I also included an excerpt from our Sleeping Bear Dunes Fishery Report that summarizes the MDNR survery in 1981, along with their net locations. It appears that not much has changed except that your esocids (pike and musky) have all but disappeared
